- Restricted Stock Units granted pursuant to the Albany International Corp. 2003 Restricted Stock Unit Plan (the "Restricted Stock Unit Plan"). Each Restricted Stock Unit entitles the holder to receive the cash equivalent of one share of Class A Common Stock at the time of vesting or, in the event that the holder elects to defer payment, at such later time elected in accordance with the Restricted Stock Unit Plan.
- (1) 200 Restricted Stock Units (plus related dividend units) vest on each November 11, beginning November 11, 2009.
  - (2) Includes dividend units accrued on Restricted Stock Units on April 5, 2013 and July 8, 2013.
  - (3) 200 Restricted Stock Units (plus related dividend units) vest on each November 11, beginning November 11, 2010.
  - (4) 200 Restricted Stock Units (plus related dividend units) vest on each November 11, beginning November 11, 2011.

- Phantom Stock Units granted on February 14, 2013 pursuant to the Albany International Corp. 2011 Performance Phantom Stock Plan (the "Phantom Stock Plan"). Each Phantom Stock Unit entitles the holder to receive the cash equivalent of one share of Class A Common Stock at the time of vesting.
- (5) 429 Phantom Stock Units will be settled and payable each year on or about March 1, beginning March 1, 2013.
