On February 4, 2015, the Board of Directors of CME Group Inc. (the "Company") approved the appointment of Jack Tobin to serve as the Company's Managing Director and Chief Accounting Officer effective as of April 1, 2015. Mr. Tobin will be replacing Jill A. Harley, who has served in this role on an interim basis since May 20, 2014. Ms. Harley will remain with the Company in a different capacity.

Mr. Tobin most recently served as our Managing Director, Corporate Finance since 2007. He has 13 years of financial services experience at the Company, CBOT Holdings, Inc. ("CBOT Holdings") and Board of Trade of the City of Chicago, Inc. ("CBOT"). Prior to our merger with CBOT Holdings, Mr. Tobin served as the Director, Corporate Finance for CBOT Holdings and CBOT from 2002 to 2007. Prior to joining CBOT, Mr. Tobin served as a principal consultant with PricewaterhouseCoopers from 1997 to 2002. Mr. Tobin is a registered certified public accountant.

Mr. Tobin will participate in the Company's compensation program upon terms commensurate with other executives at the level of Managing Director.

There have been no transactions, and no transactions are currently proposed, in which the Company was or is to be a participant and in which Mr. Tobin or any member of his immediate family had or will have an interest.
