This Form 8-K/A (this “Amendment”) amends the Current Report on Form 8-K of Phototron Holdings, Inc. (“we,” “us” or “our”) filed on April 9, 2012 (the “Original 8-K”), regarding the acquisition of all of the outstanding capital stock of SG Technologies Corp, a Nevada corporation (“SGT”), through a reverse merger of SGT Merger Corporation, a Nevada corporation and our wholly-owned subsidiary, with and into SGT, with SGT becoming our wholly-owned subsidiary.
