(1) On May 15, 2008, restrictions lapsed with respect to 10,500 shares of restricted stock held by Mr. Hodous. Pursuant to the terms of his restricted stock award, he elected to have the Company withhold 3,754 of such shares in order to satisfy the resulting tax withholding obligation. As a result, as of that date Mr. Hodous held 23,000 restricted shares of the Company's common stock and 14,777 shares of the Company's common stock.
