Item 8.01. Other Events.

On January 14, 2016, Finjan Holdings, Inc. (the "Company") issued a press release announcing that the Patent Trial and Appeal Board (PTAB) at the United States Patent and Trademark Office (USPTO) denied six of Symantec Corporation's petitions for Inter Partes Review (IPR) of five asserted Finjan patents. Two of the rejected petitions were directed against Finjan's U.S. Patent No.7,756,996 ('996 Patent), while the four remaining rejected petitions were directed against Finjan's U.S. Patent Nos. 8,141,154 ('154 Patent), 8,015,182 ('182 Patent), 7,930,299 ('299 Patent) and 7,757,289 ('289 Patent). The patent lawsuit filed by Finjan, Inc. in July of 2014 (CAND-3-14-cv-02998) against Symantec is expected to continue with these and three additional asserted Finjan patents, as originally filed. The other Finjan patents in the litigation are U.S. Patent Nos. 6,154,844 ('844 Patent), 7,613,926 ('926 Patent), and 8,677,494 ('494 Patent).

The rejection of Symantec's IPR petitions follows the PTAB's September 2015 rejections of two IPR petitions by Sophos Ltd. against Finjan's '494 and '926 Patents.
