Directors Deferred Compensation Plan. 3,168 of these shares of restricted stock were granted on 6/10/2014 at a price of \$31.57 per share and will be settled only for shares of KAR common stock on a one-for-one basis. These 3,168 shares of restricted stock were granted pursuant to the KAR Auction Services, Inc. 2009 Omnibus Stock and Incentive Plan and one-fourth of the grant vests every three months from the date of the grant and such grant is subject to forfeiture until vested.

- (4) Reflects dividend payment of which 14 shares are vested and the remaining shares will vest as follows: 6 shares vest on 9/9/2014, 6 shares vest on 12/9/2014, 6 shares vest on 3/9/2015 and the remaining 6 shares vest on 6/9/2015.
