Represents director fees deferred in the reporting person's account in the KAR Auction Services, Inc. Directors Deferred Compensation Plan. 2,620 shares of restricted stock were granted on 6/3/2015 at a price of \$38.18 per share and will be settled only for shares of KAR common stock on a one-for-one basis. These 2,620 shares of restricted stock were granted pursuant to the KAR Auction Services, Inc. 2009 Omnibus Stock and Incentive Plan and one-fourth of the grant vests every three months from the date of the grant and such grant is subject to forfeiture until vested.
- (3) Reflects the reinvestment of dividend equivalents in additional shares of phantom stock pursuant to the terms of the KAR Auction Services, Inc. Directors Deferred Compensation Plan.
- (4) Reflects dividend payment of which 29.1638 shares are vested and the remaining shares will vest as follows: 4 shares vest on 12/2/2015, 5 shares vest on 3/2/2016, and the remaining 4 shares vest on 6/2/2016.
- (5) Reflects dividend payment of which 29.8702 shares are vested and the remaining shares will vest as follows: 4.9757 shares vest on 12/2/2015, 4.9832 shares vest on 3/2/2016, and the remaining 4.9757 shares vest on 6/2/2016.
