As per the DEF14A filed on April 30, 2012 6,201,812 shares of common stock were outstanding as of April 9, 2012. After completion of the tender offer for 924,000 shares which expired on June 13, 2012, 5,277,812 shares are presumably outstanding. The percentage set forth in item 5 was derived using such number. Bulldog Investors, Brooklyn Capital Management, Phillip Goldstein and Andrew Dakos beneficially own an aggregate of 472,999 shares of IRL or 8.96% of the outstanding shares. Power to dispose of and vote securities resides either with Mr. Goldstein, Mr. Dakos or with clients.
