FDSI is a registered broker-dealer and an investment adviser registered with the SEC. 289,300 of the Reported Shares are held in Separate Accounts managed by HCM, which is also an investment adviser registered with the SEC.

1,345,000 of the Reported Shares are held by the Hodges Fund and 57,000 of the Reported Shares are held by the Hodges Pure Contrarian Fund, both of which are series of Professionally Managed Portfolios, an investment company registered under the Investment Company Act of 1940. The investment adviser to both of these funds is HCM, which may be deemed to be a beneficial owner of the funds' Reported Shares.
