169,620 of the Reported Shares are held in separate accounts managed by FDSI, each of which, individually, owns less than 1% of the common stock of the Issuer(each a "Separate Account"). FDSI is a registered broker-dealer and an investment adviser registered with the SEC. 239,450 of the Reported Shares are held in Separate Accounts managed by HCM, which is also an investment adviser registered with the SEC.

1,295,000 of the Reported Shares are held by the Hodges Fund, 60,000 of the Reported Shares are held by the Hodges Pure Contrarian Fund and 850,000 of the Reported Shares are held by the Hodges Small Cap Fund, all of which are series of Professionally Managed Portfolios, an investment company registered under the Investment Company Act of 1940. The investment adviser to both of these funds is HCM, which may be deemed to be a beneficial owner of the funds' Reported Shares.
