1,300,000 of the Reported Shares are held by the Hodges Fund, a series of Professionally Managed Portfolios, an investment company registered under the Investment Company Act of 1940. 50,000 of the Reported Shares are held by the Hodges Pure Contrarian Fund, a series of Professionally Managed Portfolios, an investment company registered under the Investment Company Act of 1940. 275,000 of the Reported Shares are held by the Hodges Small Intrinsic Value Fund, a series of Professionally Managed Portfolios, an investment company registered under the Investment Company Act of 1940. The investment adviser to these funds is HCM, which may be deemed to be a beneficial owner of the funds' Reported Shares.
