The beneficial ownership percentage reported herein is based on 26,233,631 voting Shares issued and outstanding as of October 19, 2018, as disclosed in the Company's Quarterly Report for the quarter ended September 30, 2018, as filed with the Securities and Exchange Commission on October 24, 2018.
