**EXPLANATORY NOTE**

The Registrant filed with the Securities and Exchange Commission (the SEC ) its Registration Statement on Form S-8 (Registration No. 333-196763) on June 13, 2014 (the 2014 Registration Statement ) pursuant to and in accordance with the requirements of General Instruction E to Form S-8 for the purpose of registering under the Securities Act of 1933, as amended (the Securities Act ), 500,000 shares of Common Stock to be offered and sold under the Registrant's Amended and Restated 2014 Stock Incentive Plan (the Plan ). Pursuant to General Instruction E to Form S-8, the contents of the 2014 Registration Statement are incorporated into this Registration Statement by reference.

The Registrant filed with the SEC its Registration Statement on Form S-8 (Registration No. 333-207108) on September 24, 2015 (the 2015 Registration Statement ) pursuant to and in accordance with the requirements of General Instruction E to Form S-8 for the purpose of registering under the Securities Act an additional 600,000 shares of Common Stock to be offered and sold under the Plan. Pursuant to General Instruction E to Form S-8, the contents of the 2015 Registration Statement are incorporated into this Registration Statement by reference.

This Registration Statement on Form S-8 has been prepared and filed pursuant to and in accordance with the requirements of General Instruction E to Form S-8 for the purpose of registering under the Securities Act an additional 1,900,000 shares of Common Stock to be offered and sold under the Plan. These shares represented 1,900,000 shares of Common Stock that were added to the Plan as of July 19, 2016 by vote of the Registrant's stockholders at the Registrant's 2016 Annual Meeting of Stockholder and, in accordance with the terms of the Plan, are to be assigned to and made available for grant under the Plan.
