 - (1) The 100,000 shares were sold in 51 lots ranging from 100 shares to 11,244 shares per lot. The sale price ranged between \$36.17 and \$36.50.  - (3) Subject to the Reporting Person's continuing employment and the provisions in the Altera's standard form of stock option agreement, the options shall commence vesting at 25% of the shares on the first anniversary of the grant date and monthly thereafter such that the option will be fully vested four years after the grant date.
