Item 1.01 Entry into a Material Definitive Agreement.

On October 25, 2018, our Avis Budget Rental Car Funding (AESOP) LLC subsidiary issued \$550 million of asset-backed securities with a maturity of five years, comprised of approximately \$451 million aggregate principal amount of Series 2018-2 4.00% Class A notes, \$53.6 million aggregate principal amount of Series 2018-2 4.27% Class B notes and \$45.4 million aggregate principal amount of Series 2018-2 4.95% Class C notes. The issuer also issued \$30 million aggregate principal amount of Series 2018-2 6.326% Class R notes, which are subordinated to the Class A, Class B and Class C notes and which were issued to its sole shareholder, AESOP Leasing L.P. The notes were issued under the Series 2018-2 Supplement dated October 25, 2018, between Avis Budget Rental Car Funding (AESOP) LLC and The Bank of New York Mellon Trust Company, N.A. as trustee and as Series 2018-2 Agent, to the Second Amended and Restated Base Indenture, dated as of June 3, 2004, as amended.

The notes are secured under the Second Amended and Restated Base Indenture primarily by vehicles in our domestic fleet and other related assets. The foregoing summary of the notes is qualified in its entirety by reference to the full text of the Series 2018-2 Supplement, a copy of which is attached hereto as Exhibit 10.1 and which is incorporated by reference herein.

Certain purchasers of the notes, and the trustee, and their respective affiliates, have performed and may in the future perform, various commercial banking, investment banking and other financial advisory services for us and our subsidiaries for which they have received, and will receive, customary fees and expenses.
