The restricted stock agreement contains tax withholding features allowing stock to be withheld to satisfy tax withholding obligations. The plan is exempt under Rule 16(b)-3. Includes 1,711 shares of restricted stock which will vest on 02/14/2009, 1,428 shares which vest on 2/13/2010, 2,000 shares which vest on 11/6/2011 and 5,810 shares which vest on 02/10/2012.
