Pursuant to the terms of the RSU award agreement, the vesting and payment of these RSUs will be accelerated if there is a change-in-control of the Company. The number of RSUs was determined by dividing \$80,000 by \$36.51, the closing price of the Company's common stock on the New York Stock Exchange on the day before the grant.
