#### Item 1.01 Entry into a Material Definitive Agreement

On October 1, 2007, Select Medical Corporation (Select), SLMC Finance Corporation, a wholly-owned subsidiary of Select, (SLMC), Cedar Cliff Acquisition Corporation, a wholly-owned subsidiary of SLMC, CORA Health Services, Inc. (CORA) and Brad C. Roush, as Stockholders Agent entered into an Agreement and Plan of Merger (the Merger Agreement) pursuant to which SLMC will acquire CORA for approximately \$46 million. The purchase price is subject to adjustment based on CORA is net working capital and indebtedness on the closing date.

The transaction, which is expected to close in the fourth quarter of 2007, is subject to a number of customary closing conditions.

The foregoing description of the Merger Agreement does not purport to be complete and is qualified in its entirety by reference to the Merger Agreement. A copy of the Merger Agreement is attached to this report as Exhibit 2.1 and is incorporated by reference herein.
