By reason of the provisions of Rule 13d-3 of the Securities Exchange Act of 1934, as amended, each of (i) CR Intrinsic Investors and Mr. Cohen may be deemed to own beneficially 500,000 Shares (constituting approximately 2.0% Shares outstanding) and (ii) Sigma Management and Mr. Cohen may be deemed to own beneficially 775,000 Shares (constituting approximately 3.1% Shares outstanding).
