Pursuant to an investment management agreement, Walter Management maintains investment and voting power with respect to the securities held by Global Investments. Mr. Cohen controls each of SAC Capital Advisors, SAC Capital Management, CR Intrinsic Investments, Sigma Management and indirectly owns a 49% interest in the managing member of Walter Management. CR Intrinsic Investments is a wholly owned subsidiary of SAC Capital Associates.
