Floating Rate Mandatory Redeemable Preferred Shares, Series A and \$859,375 principal amount of JIB Group Ltd. 3.93% Senior Notes Series A due October 30, 2026 to American General Life Insurance Company ("AGL"), also an indirect wholly owned subsidiary of AIG, in exchange for \$2,000,000 principal amount of Express Scripts Holding Company 3.4% Senior Unsecured Bonds due March 1, 2027. A cash true-up of \$1,134,650.11 is also expected to be paid by UGC to AGL.
