As previously announced, Dollar Tree Stores, Inc. has released a business update for its second quarter 2006, which is available via a recorded telephone announcement beginning July 6, 2006 after 5:00 PM EST and continuing through Monday, July 10, 2006. Thank you for calling the Dollar Tree business update hotline. This is Kent Kleeberger, Chief Financial Officer.

The information on this call about our future expectations, plans and prospects constitutes forward-looking statements under the Private Securities Litigation Reform Act of 1995. Our actual results may differ materially from those indicated by these forward-looking statements as a result of various important factors, including national and international events, consumer spending, and others described in our recent Annual Report, Current Report, and Quarterly Report on file with the SEC. This information is current only as of the date presented, and we will not update this information until our official quarterly sales release scheduled for Thursday, August 3, before market opening.

Our guidance for the second quarter of fiscal year 2006, encompassing the reporting period of April 30, 2006 to July 29, 2006, was for total sales to be in the range of \$855 to \$875 million. As of July 6, the Company's sales may be characterized as trending toward the high end of this range of guidance.

Again, our official sales release for 2Q 2006 is scheduled for Thursday, August 3, 2006, before market opening.

As of July 6, 2006, Dollar Tree operated 3,146 stores in 48 states, compared to 2,845 stores in 48 states at July 7, 2005.
