On June 21 2012, as part of a ratings review of 114 European financial institutions announced in February 2012, a leading ratings agency downgraded the longer-term senior debt and deposit ratings of the Group and Lloyds Bank by one notch. The ratings agency further announced that the outlook is stable on Lloyds Bank's standalone credit assessment and negative on the senior debt and deposit ratings, reflecting the ratings agency's medium-term view of lower systemic support for UK banks. For more detail on credit ratings risks see "Risk Factors - Risks relating to the notes - You are subject to the credit risk of Lloyds Bank and LBG and their credit ratings and and credit spreads may adversely affect the notes" in the prospectus supplement and "2011 20-F Risk Factors – Financial Soundness Related Risks," in particular "– The Group's borrowing costs and access to the capital markets is dependent on a number of factors, and increased costs or reduction in access could materially adversely affect the Group's results of operations, financial condition and prospects."
