Absolute underlying return: For each underlying, the absolute value of its underlying return

Buffer amount: 30%

Payment at Maturity: For each \$1,000 stated principal amount security you hold at maturity:

- If the final underlying value of the worst performing underlying is **greater than or equal to** its initial underlying value:
 $\$1,000 +$ the upside return amount

- If the final underlying value of the worst performing underlying is **less than** its initial underlying value by an amount **less than or equal to** the buffer amount:
 $\$1,000 + (\$1,000 \times$ the absolute underlying return of the worst performing underlying)

- If the final underlying value of the worst performing underlying is **less than** its initial underlying value by an amount **greater than** the buffer amount:
 $\$1,000 + (\$1,000 \times$ the underlying return of the worst performing underlying) + \$300

If the worst performing underlying decreases from its initial underlying value to its final underlying value by more than the buffer amount, your payment at maturity will be less, and possibly significantly less, than the \$1,000 stated principal amount per security. Underlying return: For each underlying, (i) its final underlying value *minus* its initial underlying value, *divided by* (ii) its initial underlying value

Worst performing underlying: The underlying with the lowest underlying return

Selected Risk Considerations
