EXPLANATORY NOTE

This amended current report on Form 8-K/A is being filed to correct a date reference in the initial Form 8-K and to attach a voting agreement, attached hereto as Exhibit 10.3, related to the merger agreement. On September 16, 2008, EZCORP, Inc. announced that it entered a definitive merger agreement to acquire 100% of the equity ownership of Value Financial Services, Inc.
