Explanatory Note:

This Post-Effective Amendment No. 2 to Registration Statement on Form S-8, File No. 333-25245 (the Registration Statement ) is being filed to deregister certain Ordinary Shares of SkillSoft Public Limited Company (the Company ) that were registered pursuant to the Company s 1996 Supplemental Stock Plan (the Plan ).

Post-Effective Amendment No. 1 to the Registration Statement amended the Registration Statement to deregister 3,898,446 Ordinary Shares reserved for issuance under the Plan. The Registration Statement is hereby further amended to deregister an additional 1,400,000 Ordinary Shares reserved for issuance under the Plan that remain unsold.
