Effective as of December 29, 2006, Crdentia Corp. (the Company) executed an Amendment No. 1 (Amendment No. 1) to that certain Agreement and Plan of Merger, dated as of September 20, 2006, by and among the Company, iVOW Acquisition Corp. and iVOW, Inc.
