Effective February 17, 2012, Randy W. Wright was appointed the Vice President and Controller of Huntsman Corporation (the Company). Mr. Wright most recently served as the Company's Assistant Controller and Director of Financial Reporting. He joined the Company in 2004. Mr. Wright replaces L. Russell Healy as Controller, whose retirement was previously reported by the Company.

Mr. Wright will receive salary, cash performance awards and stock-based equity compensation, and will participate in other benefit and compensation plans, at levels consistent with his seniority and scope of responsibility.
