- (1) 1. The Reporting Person entered into a Convertible Debenture (the "Debenture") in the amount of \$600,000 with the Issuer effective April 28, 2006. Under the terms of the Debenture, the reporting Person has the option to convert all or any portion of the principal amount into shares of the Issuer's common stock at the rate of \$6.55 per share, subject to adjustment under certain conditions. The Debenture provides, absent shareholder approval, that the number of shares of our common stock that may be issued to or acquired by the Reporting Person upon conversion of the Debenture shall not exceed 19.99% of the total number of issued and outstanding shares of the Issuer's common stock.
