- On November 3, 2011, the reporting person was granted 40,000 restricted stock units under the Silgan Holdings Inc. 2004 Stock Incentive Plan, as amended, subject to the satisfaction of certain performance criteria for the Issuer's 2012 fiscal year. The performance criteria for the Issuer's 2012 fiscal year was determined to have been met upon the finalization of the Issuer's audited financial statements for 2012. Accordingly, these restricted stock units are no longer subject to cancellation. These restricted stock units will vest all at once on November 3, 2016 and will be settled in shares of Common Stock on a 1-for-1 basis.

(2) These securities are restricted stock units that were granted on March 1, 2013 under the Silgan Holdings Inc. 2004 Stock Incentive Plan, as amended. These restricted stock units vest ratably over a 5 year period beginning March 1, 2014 and will be settled in shares of Common Stock on a 1-for-1 basis upon vesting.
