This Amendment No. 1 (this "Amendment") amends, as set forth below, the statement on Schedule 13D, dated December 11, 2015 and filed with the SEC on February 9, 2018 (the "Original Schedule 13D, for Bank of America Corporation ("BAC") and Blue Ridge Investments, L.L.C ("Blue Ridge") (collectively, the "Reporting Persons") with respect to the auction rate preferred shares ("ARPS ") of Eaton Vance Michigan Municipal Bond Fund (the "Issuer" or the "Company"). This Amendment is being filed by the Reporting persons as a result of the March 26, 2018 full redemption by the Issuer of all of its ARPS held by the Reporting Persons.
