**ITEM 8.01. Other Events**

On December 6, 2005, Syniverse Technologies, Inc. (the Company ) issued a press release announcing the extension of its offer to exchange up to \$175,000,000 principal amount of its Series B 7<sup>3</sup>/<sub>4</sub>% Senior Subordinated Notes due 2013 for any and all outstanding 7<sup>3</sup>/<sub>4</sub>% Senior Subordinated Notes due 2013. The exchange offer, originally scheduled to expire at 5:00 p.m., New York City time, on December 5, 2005, has been extended and will now expire at 5 p.m., New York City time, on December 8, 2005, unless further extended. All terms of the exchange offer remain the same.

The new notes have substantially identical terms of the original notes, except that the new notes have been registered under the Securities Act of 1933, as amended.

A press release announcing the extension of the exchange offer is attached hereto as Exhibit 99.1.
