On April 25, 2008, The Colonial BancGroup, Inc. (BancGroup) announced that it had completed its previously announced public offering of 43.7 million shares of its common stock at \$8.00 per share for total net proceeds of approximately \$333 million. The over-allotment of 5.7 million shares was exercised and included in the total shares sold. The press release is attached hereto as Exhibit 99.1 and is incorporated herein by reference.
