ChipMOS REPORTS MAY 2008 REVENUES

Hsinchu, Taiwan, June 16, 2008 ChipMOS TECHNOLOGIES (Bermuda) LTD. (ChipMOS or the Company) (NASDAQ: IMOS) today reported its unaudited consolidated revenues for the month of May 2008.

Revenues for the month of May 2008 were NT\$1,563.3 million or US\$51.5 million, a decrease of 5.6% from the month of April 2008 and a decrease of 20.9% from the same period in 2007. (All translations from NT dollars to U.S. dollars were made at the exchange rate of NT\$30.37 against US\$1.00 as of May 30, 2008.)
