Mosaic Global Holdings Inc., a wholly-owned subsidiary of The Mosaic Company, is redeeming all remaining outstanding \$3,525,000 aggregate principal amount of its 10.875% Senior Notes due 2013 (the Notes ) on August 1, 2008 pursuant to the terms of the Indenture dated as of August 1, 2003 relating to the Notes. The Notes are being redeemed at a price of \$1,054.38 per \$1,000 principal amount. Accrued and unpaid interest of \$54.375 per \$1,000 in principal amount of the Notes to the redemption date will be paid to the holders of the redeemed notes registered on the regular record date of July 15, 2008.
