ChipMOS REPORTS FEBRUARY 2009 REVENUE

Hsinchu, Taiwan, February 19, 2009 ChipMOS TECHNOLOGIES (Bermuda) LTD. (ChipMOS or the Company) (NASDAQ: IMOS) today reported its unaudited consolidated revenue for the month of February 2009.

Revenue for the month of February 2009 was NT\$781.0 million or US\$22.3 million, an increase of 7.5% from the month of January 2009 and a decrease of 47.3% from the same period in 2008. (All translations from NT dollars to U.S. dollars were made at the exchange rate of NT\$35.00 against US\$1.00 as of February 27, 2009.)
