As a result of these relationships, each of SCP V, Sun Partners V Ltd., Sun Advisors V, Leder and Krouse has shared voting and dispositive power with respect to the shares of Common Stock directly held by Sun Cardinal.

Through a revocable trust, each of Leder and Krouse own 50% of the membership interests in Sun Securities, LLC, which in turn is the general partner of Sun Securities Advisors, which is in turn the general partner of Sun Securities Fund. As a result of these relationships, each of Sun Offshore, Sun Securities Fund, Sun Securities LLC, Sun Securities Advisors, Leder and Krouse has shared voting and dispositive power with respect to the shares of Common Stock directly held by SCSF Cardinal.

(b) Percent of class: In the aggregate, the Reporting Persons beneficially own 20,050,409 shares of the Common Stock, or 54.6% of the total number of shares outstanding, by virtue of the 15,037,793 shares of Common Stock directly held by Sun Cardinal and the 5,012,616 shares of Common Stock directly held by SCSF Cardinal.
