- (1) This amendment includes 4,694 shares of Hanesbrands Inc. common stock that were beneficially owned by the Reporting Person at the time of the filing of a Form 3 by the Reporting Person on February 4, 2008, but were inadvertently omitted from the total beneficial ownership reported on that Form 3.
- (2) The options vest in two equal installments on August 31, 2007 and August 31, 2008.
- (3) The options vest in three installments of 33% on September 26, 2007, 33% on September 26, 2008 and 34% on September 26, 2009.
- (4) The options were immediately exercisable upon grant on September 26, 2006.
- (5) The options vest in three installments of 33% on February 5, 2008, 34% on February 5, 2009 and 33% on February 5, 2010.
