### Introduction

This Amendment No. 5 to Schedule 13D (this *Statement*) relates to the beneficial ownership of Common Stock, \$0.001 par value per share (the *Shares*) of ICF International, Inc., a Delaware corporation (the *Issuer*). This Statement is being filed on behalf of the Reporting Persons and amends and supplements the Schedule 13D filed by the Reporting Persons dated October 11, 2013, as heretofore amended. Unless otherwise defined, all capitalized terms used herein shall have the respective meanings given such terms in the initial Schedule 13D.

#### Interest in Securities of the Issuer.

As of February 29, 2016, each Reporting Person beneficially owned 949,765 Shares, which represented 4.94% of the outstanding Shares, based upon 19,223,827 Shares outstanding on October 23, 2015, as reflected in the Issuer s Form 10-Q filed October 30, 2015.

In accordance with Securities and Exchange Commission Release No. 34-39538 (January 12, 1998) (the *Release*) this filing reflects the securities beneficially owned by PCC and certain of its subsidiaries, including Sagard. The filing does not reflect securities beneficially owned, if any, by any subsidiaries of PCC whose ownership of securities is disaggregated from that of PCC in accordance with the Release.
