- (1) On August 2, 2012, the Reporting Person received a grant of restricted stock units ("RSUs") covering 4,700 shares of KLA-Tencor common stock. On August 2, 2015, the Reporting Person vested in twenty-five percent (25%) of such RSUs.
- (2) Pursuant to the terms of the August 2, 2012 RSU grant described in note (1) above, 437 shares of KLA-Tencor common stock were automatically withheld at vesting to cover required tax withholding. Because the vesting date of such RSUs occurred on a day on which the NASDAQ Stock Market was closed for trading, the fair market value of KLA-Tencor common stock used for purposes of calculating

the number of shares to be withheld was the closing price of KLA-Tencor common stock as reported on the NASDAQ Stock Market on the last completed trading day immediately prior to such vesting date.

(3) This sale was effected pursuant to the terms of a Rule 10b5-1 trading plan adopted by the Reporting Person on March 11, 2015.

(4) Each RSU represents a contingent right to receive one share of KLA-Tencor common stock.

(5) regarding the achievement of the applicable performance goals. Any such holdings will be reported on a Form 4 within two business days of the date such assessment is made.
