Glenview Capital Management serves as investment manager to each of Glenview Capital Partners, Glenview Capital Master Fund, Glenview Institutional Partners, Glenview Offshore Opportunity Master Fund, Glenview Capital Opportunity Fund, GCM Master Fund and the Managed Account. Mr. Robbins is the Chief Executive Officer of Glenview Capital Management.

This amount consists of: (A) 73,944 Shares held for the account of Glenview Capital Partners; (B) 1,199,752 Shares held for the account of Glenview Capital Master Fund; (C) 582,777 Shares held for the account of Glenview Institutional Partners; (D) 801,217 Shares held for the account of Glenview Offshore Opportunity Master Fund; (E) 554,975 Shares held for the account of Glenview Capital Opportunity Fund; (F) 614,286 Shares held for the account of GCM Master Fund; and (G) 361,309 Shares held for the Managed Account.
