Partners, as the general partner of BVF and BVF2, the manager of BVLLC and the investment adviser of ILL10, may be deemed to beneficially own the 6,719,657 shares of Common Stock beneficially owned in the aggregate by BVF, BVF2, BVLLC and ILL10.

BVF Inc., as the general partner of Partners, may be deemed to beneficially own the 6,719,657 shares of Common Stock beneficially owned by Partners.

The foregoing should not be construed in and of itself as an admission by any Reporting Person as to beneficial ownership of any shares of Common Stock owned by another Reporting Person. As of the date hereof, (i) BVF may be deemed to beneficially own approximately 3.8% of the outstanding shares of Common Stock, (ii) BVF2 may be deemed to own approximately 2.6% of the outstanding shares of Common Stock, (iii) BVLLC may be deemed to own approximately 9.4% of the outstanding shares of Common Stock, (iv) ILL10 may be deemed to beneficially own approximately 1.0% of the outstanding shares of Common Stock and (v) each of Partners, BVF Inc. and Mr. Lampert may be deemed to beneficially own approximately 16.8% of the outstanding shares of Common Stock.
